Equine Release, Waiver and Indemnification for the October 16, 2011 Trail Ride in the Park, sponsored by the Loudoun Horse Association, the Tri-State Riding Club, the United States Trail Ride, Inc.

The undersigned participant, and his or her legal guardian if the participant is under the age of 18 years, does/do hereby execute this release, waiver, indemnification for himself or herself/themselves and his or her/their heirs, successors, representatives, and assigns, acknowledges the inherent risk involved in riding and working around horses, which risks include bodily injury from using, riding or being in close proximity to horses among other risks, and further that both horse and rider can be injured in normal use or in trail riding, lessons, schooling or competition.

In Consideration of the above information, the undersigned does hereby agree to hold harmless and indemnify and further release the Loudoun Horse Association (LHA), the Tri-State Riding Club (TSRC), the United States Riding Club, Inc. (USTR), its members, agents or representatives, from any and all liability, loss, damage, costs, claims, and/or causes of action, including but not limited to all bodily injuries and property damage arising out of participation in the Trail Ride on October 16, 2011 (or on the rain date of October 23, 2011), it being specifically understood that said activity includes the handling and/or riding of equines by the undersigned participant, or responsibility for accident, damage, injury or illness to Undersigned on the premises of facilities owned, used, donated to, or leased by the County of Loudoun, VA, the Loudoun Horse Association, the Tri-State Riding Club, and the United States Trail Ride, Inc..

I fully understand that horseback riding of all types, including but not limited to lessons, clinics, trail riding, , cross-country riding, fox hunting, (which includes riding over fences, other obstacles, and steep and rough terrain) are very dangerous activities. Pursuant to Title 3.2, Chapter 62 – Equine Activity Liability - of the Code of Virginia, I execute this waiver of my rights to sue and agree to assume all risks inherent in equine activities and have notice of all risks inherent in equine activities including (i) the propensity of an equine to behave in dangerous ways which may result in injury to the participant or other persons, (ii) injury to both riders and horses in normal use including trail riding, (iii) the inability to predict an equine’s reaction to sound, movements, objects, persons or animals, (iv) hazards of surface or subsurface conditions and riding over unknown terrain where hazards may be hidden by vegetation or development, (v) collisions with other animals or objects, and (vi) the potential of a participant or bystander acting in a negligent manner that may contribute to the injury of participant or others, failure to maintain control over the horse or not acting within the participant’s ability. I wish to participate in these activities knowing they are dangerous.

In exchange for being permitted to participate in the Trail Ride in the Park and associated activities, for myself, my heirs, successors, representatives, assigns and legal representatives, I release and agree not to make or bring any claim of any kind against the Association, nor its officers, directors, members, instructors, or guests, or any landowners, landholders or the persons making property available, for any injury (including death), to me or any damage to my property whether from anyone’s negligence or not, or any other cause, arising out of my participation in these dangerous horseback riding or related activities; and I also agree if anyone makes any claims because of any injury to me (including death), or for any damage to my property, I will keep all those released by this agreement free of any damages or costs because of those claims. Furthermore, my signature hereby indicates my agreement to wear a protective helmet at all times while participating in this activity and to obey all rules set forth by the above named organizations associated with this event..

This waiver is in force for the October 16, 2011 Trail Ride in the Park (or the October 23, 2011 rain date).
